TREASURER'S REPORT

Treasurer Gayle Crompton read the Treasurer's Report for November 2022. Cash on hand as of November 1, 2022 was \$5,527,691.02. Income as of November 30, 2022 was \$52,394.11. Disbursements as of November 30, 2022 were \$390,984.09. Transfers/adjustments – Adjustment to the Corporate Fund due to a voided check in the amount of \$7.20. Cash on hand as of November 30, 2022 was \$5,189,108.24.

Gayle Crompton moved the Board approve the November 2022 Treasurer's Report as presented, with the payment of the December 15, 2022 bills of \$104,897.24 and the December 9, 2022 payroll of \$119,753.60. Personal Property Replacement Tax received for FY 2022-2023 was \$144,518.28. The Lockport Township estimate for FY 2022-2023 has not yet been received.

2021 Levy Real Estate Distributions and Interest received to date was \$6,044,689.04. Percent received to date is 99.04%.

Additional information regarding interest rates – the PMA Investments Report was reviewed.

In addition to his written report Scott Pointon said that the deadline for Library Trustee candidates to file their petitions was 5:00p.m. Monday, December 19, 2022. The four candidates who will be on the ballot in April 2023 are Nancy Hackett, Ann Lopez-Caneva, Selina Boersma, and Patricia Colella.

Scott Pointon mentioned that the White Oak Library Foundation has raised over \$28,000 in the past year. He commended Patricia Jarog and the Foundation Board for a job well done.
