**TREASURER'S REPORT**

Treasurer Adam Sulich read the Treasurer's Report for December 2010. Cash on hand as of December 1, 2010 was \$24,248,568.07. Income as of December 31, 2010 was \$175,674.13. Disbursements as of December 31, 2010 were \$333,271.01. Transfers/adjustments were \$104.06 to the Corporate Fund for a voided check. Cash on hand as of December 31, 2010 was \$24,091,075.79. Cash on hand in the Bond Account as of December 31, 2010 was \$22,038,795.49.

*Adam Sulich moved to approve the December 2010 Treasurer's Report as presented, with the payment of the January 14, 2011 bill for \$95,080.91, the January 5, 2011 payroll of \$76,654.37, and the January 19, 2011 payroll of \$72,841.93. Danny Gaddis seconded the motion. Roll call indicated: Ayes—Ron Alberico, Deanna Amann, Gayle Crompton, Danny Gaddis, Ann Lopez-Caneva, Christine Siegel, and Adam Sulich. Nays—none. Motion carried.*

Personal Property Replacement Tax received to date was \$160,193.97. The township estimate to be received for FY 2010-2011 is \$250,744.08.

2009 Levy Real Estate Distribution and Interest received to date totaled \$2,827,341.17. The total 2009 distribution percentage received to date is 99.694%.

The current interest rates as of January 25, 2011 for money market accounts are as follows: Harris Bank—0.121% and Illinois Funds—0.132%.
